# From the Corner Room October 2023 

The warm days of summer are gone. Evenings are cool, days are pleasant. It will not be long before Second Quarter begins which means the First Semester is half over already.

The students are working hard on projects, learning how to complete work forms, finishing orders, and preparing food. Each day at least one student asks, "What are we cooking today?"

Intro to Design class is completing a unit on color. They have worked with the color wheel, hue, intensity, and value. This month they will be completing a color scheme unit that involves choosing a color scheme for a paper shoe, garments, and check out color schemes of cars.

The PBL students are working on a variety of projects. Cardboard swords, shields, and helmets being created. Some food preparation and miscellaneous projects are thrown into the mix. These can be found on my web page on the school website.

Seniors are learning about the different types of relationships. This includes the dating relationship, how to handle a broken relationship, what a healthy relationship looks like, and what are the characteristics of an unhealthy relationship. This unit also teaches students communication skills, and personal skills that I hope they will use in the coming months and years.

The Foods classes are completing units on Fruits, Dairy, and Egg preparation. Each group research information about the topic and presents it to the class. They learn how to purchase and store fruits, dairy and egg products as well as the nutritional value of each. They prepare a microwave recipe, a stove top recipe, and an oven recipe for each unit.

A regular meeting of the District 69 Board of Education, Pawnee County, was held on Thursday, September 14th, at 7:30 p.m., the meeting being open to the public and proceeded in notice as required by law. Notice of this meeting was given to the President and all members of the Board and a copy of the acknowledgement of notice and the agenda is noted in the minutes. Availability of the agenda was communicated to the public in advanced notice and to the President of the Board and all Board members.

The meeting was called to order, the Open Meetings Law poster recognized, and verbal notice that the meeting was recorded was given by the President and on a roll call vote, the following members were present: Bredemeier, Howell, Mencl, Rule, Searcey, and Wehrbein. Excused Absence: none. Also present: Rick Kentfield and two visitors. The agenda was reviewed. Moved by Wehrbein and seconded by Howell "to approve the agenda as presented." Those voting in favor of said motion: Howell, Mencl, Rule, Searcey, Wehrbein, and Bredemeier. Those opposed: none. Motion carried, 6-0.

Visitor comments. A visitor shared concern about the district's bullying policy.

Moved by Howell and seconded by Bredemeier "to approve Consent Agenda items which included the August 15th board meeting minutes, August 31st board meeting minutes, September treasurer's report, September payroll in the amount of $\$ 264,076.38$, September claims in the amount of \$193,690.87, and Jessica Cutshall's employment agreement. Those voting in favor of said motion: Mencl, Rule, Searcey, Wehrbein, Bredemeier, and Howell. Those opposed: none. Motion carried, 6-0.

Discussion was held regarding financing the new press box, bleachers, concession stand, and restrooms. Rick Kentfield was directed to sign and return the contract to BluCor Construction, located in Lincoln, Nebraska as prepared and presented by Mike Fakler, owner of Fakler Architects. No formal action was taken.

Discussion was held regarding facility projects. Rick Kentfield updated the board on the progress of the new agricultural building. No formal action was taken.

Discussion was held regarding the district's bullying policy \#5054. Visitor comments made
earlier in the meeting were considered and future practices, procedures, and solutions were identified. No formal action was taken.

Moved by Howell and seconded by Searcey "to approve 2023-2024 Budget for Pawnee County School District 67-0069 as presented." Those voting in favor of said motion: Bredemeier, Howell, Mencl, Rule, Searcey, and Wehrbein. Those opposed: none. Motion carried, 6-0.

Moved by Searcey and seconded by Bredemeier "to approve the Property Tax Resolution No. 23-24 for Pawnee County School District 67-0069 as presented." Those voting in favor of said motion: Howell, Mencl, Rule, Searcey, Wehrbein, and Bredemeier. Those opposed: none. Motion carried, 6-0.

Moved by Searcey and seconded by Mencl "to approve the correspondence shared with the Gage County Zoning and Planning Board on behalf of Lewiston Consolidated Schools and support Rick Kentfield, Superintendent, accepting the invitation from Roger Harris, Gage County Attorney, to attend the September 19, 2023, at 3:00 p.m. in the EOC Conference room at the Gage County Courthouse as a school representative to provide input regarding school transportation and road safety." Those voting in favor of said motion: Mencl, Rule, Searcey, and Bredemeier. Those opposed: Wehrbein and Howell. Motion carried, 4-2.

Discussion was held regarding a resolution to increase the school district's growth percentage base used to determine the school's property tax request by up to $7 \%$. No formal action was taken.

Juli Smith, Principal, reported several school activities and initiatives.

Rick Kentfield, Superintendent, reported on the Four Counties Collaborative Activity, summer weights supervisor salary increase, $7 / 8$ grade cheerleading, and adding an FFA advisor position.

Board Committee Report - There were no reports at this time.

Moved by Howell and seconded by Wehrbein "to adjourn at 9:05 p.m.". Those voting in favor of said motion: Rule, Searcey, Wehrbein, Bredemeier, Howell, and Mencl. Those opposed: none. Motion carried, 6-0.
