### Superintendent's Message

Preparations for the new school year are moving full speed ahead and it's time once again to start making your back to school plans. This newsletter has all of the back to school information you need in preparation for another school year. Important dates you need to be aware of to start the new year includes football and volleyball practices starting on Monday, August 7, an Open House for PK to 12<sup>th</sup> grades on Tuesday, August 15, a mandatory parent and child (grades 7-12) technology boot camp on Thursday August 17 (time to be determined) and the first day of school (full day) Wednesday, August 16.

I'm excited to announce Ms. Adrian Bowen will be serving as the PK-12 Principal this year. Ms. Bowen started on July 1<sup>st</sup> and has been working with staff the past few weeks in preparation for the upcoming year. Ms. Bowen brings a wealth of knowledge and experience to the district and will do a wonderful job of providing educational leadership for the students and staff at Lewiston Consolidated Schools.

I'm also excited to announce the addition of a wonderful new group of support staff members for the upcoming school year. Lisa Cerveny will be serving as the front office secretary. Lisa lives in Beatrice and currently works as an office manager at the Beatrice Hospital. Lisa's husband, Brian, works for BNFS Railroad and they have twin boys Ethan and Tyson that attend Lewiston School and will be 3<sup>rd</sup> graders next year. New paraprofessionals include: Carla Tracy - Carla lives outside Virginia and her son Raustin attends Lewiston school and will be in 3<sup>rd</sup> grade next year. Mikayla Inderlied - Mikayla lives in Virginia and has two sons that attend Lewiston, Ethan will be in 1<sup>st</sup> grade and Grayson will be in PK 4. Allana Deane - Allana lives in Beatrice and is a 2007 graduate of Lewiston. Her son Kason attends Lewiston school and will be a Kindergartener next year. Tonya Eubanks - Tonya lives by Summerfield, KS and has two kids attending Lewiston, Anderson will be a 4<sup>th</sup> grader and Piper will be in PK4.

As in the past, we encourage all free and reduced lunch applications as we receive federal reimbursement for all free and reduced meals served to eligible individuals. Lunch prices for the 17-18 school year are \$2.35 for PK-6, \$2.85 for grades 7-12, and \$3.35 for adults. Breakfast prices are \$1.60 for PK-6, \$1.80 for grades 7-12, and \$1.85 for adults. Just a reminder that snack milk for the PK and Kindergarten students is NOT a part of the free and reduced lunch program so each of those children will be charged \$0.40 for snack milk each day. Please return your application for free and reduced lunch to the school as soon as possible. The policy remains that meals will need to be paid for in advance at the Principal's office. If you do not qualify for free lunches, it will be your responsibility to pay for your child's meals in advance. Students with no money in their lunch account will be required to bring their lunch. Again this year, admission to all home activities will be free for students attending Lewiston Consolidated Schools.

Also included in this newsletter is information regarding the school calendar, lunch menu, elementary supplies list and several required notices.

The purpose of this newsletter is to provide basic information for the Lewiston Consolidated School District that will keep all citizens informed on important school procedures, issues, and facts. This newsletter will be distributed to all patrons on the Lewiston Consolidated School mail routes. ### **ASBESTOS**

### NOTICE CONCERNING STAFF QUALIFICATIONS

The No Child Left Behind Act of 2001 gives parents the right to get information about the professional qualifications of their child's classroom teacher. Upon request, Lewiston Consolidated Schools will provide the following information to parents:

- The status of the professional qualifications of the students' classroom teacher in regard to licensing criteria for the grade levels and subject areas taught, as well as the baccalaureate and advanced degrees held, and the field of certification.
- Information concerning where a teacher is teaching under emergency or provisional status through which state qualifications have been waived, and timely notice if their child has been taught for four or more consecutive weeks by a teacher who is not highly qualified.

### ADMISSION PRICES & SENIOR CITIZEN PASSES

Admission prices for home athletic contests will remain at \$5.00 for adults and \$4.00 for non-Lewiston students this year. All Lewiston students are admitted to all home regular season events for free. Senior citizens (60 or older who live in the Lewiston school district) qualify for a free pass. If you already have a senior citizen pass, it's still valid. If you don't have one, call the school office.

### **BUS ROUTES**

The school will contact households with route information the week prior to school starting. If you are new to our school and are not sure if you are on one of our bus routes, please call the school.

### **EDUCATION**

Handicapped children between birth and twenty-one years of age are eligible for special education services. In order to be eligible, the child must meet specific criteria for mental retardation, emotional disturbance, severe developmental delay, or be deaf, blind, or multiply handicapped. If you believe your child may qualify for this program, please contact the school administration so arrangements for diagnosis can be made. All these services are provided through the Lewiston Consolidated Schools.

### REQUIRED PHYSICALS

All athletes in grades 7-12 will need to have a school physical before participating. Required forms are available in the school office. All sports physicals need to be completed and returned to the school on or before the first day of practice. Also, if you have a 6th grader going into 7th grade, they will need to have a school physical taken. Also, any new kindergarten students or any students new to the state of Nebraska will need to provide us with a physical as well as with all current immunization records and a copy of your official birth certificate. ### **Child Find**

All children with disabilities residing in the district, including children with disabilities attending non-public schools, regarding of the severity of their disabilities, and who are in need of special education and related services, are identified, located, and evaluated and a practical method is developed and implemented to determine which children with disabilities are currently receiving needed special education and related services. 92NAC 51-006.01.

- 1. All children with disabilities, including children with disabilities attending nonpublic schools, regardless of the severity of their disabilities, and who are in need of special education and related services, are identified, located and evaluated and a practical method is developed and implemented to determine which children with disabilities are currently receiving needed special education and related services. For infants and toddlers, districts shall demonstrate targeted efforts to meet the needs of children from historically underserved populations, particularly minority, low-income, inner city and rural populations.
  - a. The Child Find requirements apply to highly mobile children with disabilities (such as migrant and homeless children); and
  - A child who is suspected of being a child with a disability and in need of special education; even though they are advancing from grade to grade.

METHODS: Efforts to locate and evaluate resident children and students with disabilities who will benefit from special education and related services will be conducted on an ongoing basis in the following ways.

- a. The district as required will conduct health and general education screenings by Nebraska state statutes and Nebraska Department of Education and Nebraska Department of Health and Human Services regulations.
- b. Child find plans will be developed and records maintained to document all such activities of the district and to evaluate their effectiveness. Such records will include a copy of all public announcements. Persons making referrals will be asked where they acquired the information that led them to the school district.
- c. The district will accept referrals for evaluation directly from parents other agencies or school personnel for children below age five who may benefit from the provision of special education services. The district will conduct periodic screening activities to locate children with disabilities.

### Dear Parent/Guardian:

Children need healthy meals to learn. Lewiston Consolidated School offers healthy meals every school day. Breakfast for grades PK-6 costs \$1.60 and for grades 7-12 costs \$1.80; lunch for grades PK-6 costs \$2.35 and for grades 7-12 costs \$2.85. Your children may qualify for free or reduced price meals. Reduced price is \$0.30 for breakfast and \$0.40 for lunch. If your child(ren) qualified for free or reduced price meals at the end of last school year, you must submit a new application by **September 27** in order to avoid an interruption in meal benefits.

This packet includes an application for free or reduced price meal benefits and a set of detailed instructions. Below are some common questions and answers to help you with the application process.

- 1. WHO CAN GET FREE OR REDUCED PRICE MEALS?
  - All children in households receiving benefits from the Supplemental Nutrition Assistance Program (SNAP), Temporary Assistance for Needy Families (TANF) or the Food Distribution Program on Indian Reservations (FDPIR) are eligible for free meals.
  - Foster children that are under the legal responsibility of a foster care agency or court are eligible for free meals.
  - Children participating in their school's Head Start program are eligible for free meals.
  - Children who meet the definition of homeless, runaway, or migrant are eligible for free meals.
  - Children may receive free or reduced price meals if your household's income is within the limits on the Federal Income Eligibility Guidelines. Your children may qualify for free or reduced price meals if your household income falls at or below the limits on this chart.
- 2. HOW DO I KNOW IF MY CHILDREN QUALIFY AS HOMELESS, MIGRANT, OR RUNAWAY? Do the members of your household lack a permanent address? Are you staying together in a shelter, hotel, or other temporary housing arrangement? Does your family relocate on a seasonal basis? Are any children living with you who have chosen to leave their prior family or household? If you believe children in your household meet these descriptions and haven't been told your children will get free meals, please call or e-mail [school, homeless liaison or migrant coordinator].
- 3. DO I NEED TO FILL OUT AN APPLICATION FOR EACH CHILD? No. Use one Free and Reduced Price School Meals Application for all students in your household. We cannot approve an application that is not complete, so be sure to fill out all required information. Return the completed application to: Lewiston Consolidated School, 306 Tiger Avenue, Lewiston, NE 68380; 402-865-4675.
- 4. SHOULD I FILL OUT AN APPLICATION IF I RECEIVED A LETTER THIS SCHOOL YEAR SAYING MY CHILDREN ARE ALREADY APPROVED FOR FREE MEALS? No, but please read the letter you got carefully and follow the instructions. If any children in your household were missing from your eligibility notification, contact Lewiston Consolidated School, 306 Tiger Avenue, Lewiston, NE 68380; 402-865-4675 immediately.
- 5. CAN I APPLY ONLINE? At this time, you are unable to apply online.

- 6. MY CHILD'S APPLICATION WAS APPROVED LAST YEAR. DO I NEED TO FILL OUT A NEW ONE? Yes. Your child's application is only good for that school year and for the first few days of this school year. You must send in a new application unless the school told you that your child is eligible for the new school year. If you do not send in a new application that is approved by the school or you have not been notified that your child is eligible for free meals, your child will be charged the full price for meals.
- 7. I GET WIC. CAN MY CHILDREN GET FREE MEALS? Children in households participating in WIC <u>may</u> be eligible for free or reduced price meals. Please send in an application.
- 8. WILL THE INFORMATION I GIVE BE CHECKED? Yes. We may also ask you to send written proof of the household income you report.
- 9. IF I DON'T QUALIFY NOW, MAY I APPLY LATER? Yes, you may apply at any time during the school year. For example, children with a parent or guardian who becomes unemployed may become eligible for free and reduced price meals if the household income drops below the income limit.
- 10. WHAT IF I DISAGREE WITH THE SCHOOL'S DECISION ABOUT MY APPLICATION? You should talk to school officials. You also may ask for a hearing by calling or writing to: **Mr. Rick Kentfield, 306 Tiger Avenue, Lewiston, NE 68380, 402-865-4675**.
- 11. MAY I APPLY IF SOMEONE IN MY HOUSEHOLD IS NOT A U.S. CITIZEN? Yes. You, your children, or other household members do not have to be U.S. citizens to apply for free or reduced price meals.
- 12. WHAT IF MY INCOME IS NOT ALWAYS THE SAME? List the amount that you <u>normally</u> receive. For example, if you normally make \$1000 each month, but you missed some work last month and only made \$900, put down that you made \$1000 per month. If you normally get overtime, include it, but do not include it if you only work overtime sometimes. If you have lost a job or had your hours or wages reduced, use your current income.
- 13. WHAT IF SOME HOUSEHOLD MEMBERS HAVE NO INCOME TO REPORT? Household members may not receive some types of income we ask you to report on the application, or may not receive income at all. Whenever this happens, please write a 0 in the field. However, if any income fields are left empty or blank, those will also be counted as zeroes. Please be careful when leaving income fields blank, as we will assume you meant to do so.
- 14. WE ARE IN THE MILITARY. DO WE REPORT OUR INCOME DIFFERENTLY? Your basic pay and cash bonuses must be reported as income. If you get any cash value allowances for off-base housing, food, or clothing, it must also be included as income. However, if your housing is part of the Military Housing Privatization Initiative, do not include your housing allowance as income. Any additional combat pay resulting from deployment is also excluded from income.
- 15. WHAT IF THERE ISN'T ENOUGH SPACE ON THE APPLICATION FOR MY FAMILY? List any additional household members on a separate piece of paper, and attach it to your application. Contact Lewiston Consolidated School, 306 Tiger Avenue, Lewiston, NE 68380; 402-865-4675 to receive a second application.

### Instructions for Completing the Free & Reduced Price School Meals Family Application

For households receiving benefits from the Supplemental Nutrition Assistance Program (SNAP), Temporary Assistance for Needy Families (TANF) or the Food Distribution Program on Indian Reservations (FDPIR), follow these instructions:

- Part 1: List each child's name, the school they attend and their grade.
- Part 2: Enter household's Master Case Number if the household qualifies for SNAP, TANF or FDPIR.
