Moved by Sisco and seconded by Janssen "to approve the bus camera quote provided by Cornhusker International in the amount of \$9,500 for the purchase and installation of 5 new camera systems." Those voting in favor of said motion: Sisco, Janssen, Schuster and Searcey. Those opposed: none. Motion carried, 4-0.

Moved by Sisco and seconded by Janssen "to approve the newly proposed Food Coordinator positions at 4.5% each and all other assignments listed on the 2020-2021 extra duty list." Those voting in favor of said motion: Janssen, Schuster, Searcey and Sisco. Those opposed: none. Motion carried, 4-0.

Moved by Schuster and seconded by Janssen "to approve the base bid floor plan as presented and the alternate bid floor plan with the modification of replacing the 14foot overhead door on the south side of the building with a 20-foot-wide overhead on the south side of the building."
