If you miss the regular deadline, you may register during the late period but must pay the additional nonrefundable late fee. NOTE: All materials sent by mail must be RECEIVED by the last date of the late period, regardless of when they are postmarked. If students are wishing to register at school, he/she must have their social security number and a credit card to pay for registration.

TEST FEES Registration for the ACT without writing is \$68.00. ACT with writing costs \$93.00. Juniors and Seniors qualifying for F/R Lunch may see Mrs. Houston for a fee waiver.
